## Dee Barker Collection, 1894-2012

### Descriptive Summary

**Title:** Dee Barker Collection, 1894-2012

**Summary:**

Dee Barker's collection reflects her leadership roles within the Tarrant County Historical Commission (TCHC) and as a resident of Colleyville, as well as her husband, Jesse Barker's long association with Bell Helicopter's Customer Training Academy. Barker served on the TCHC (1977-2009) and as Chairman of the TCHC in 1987 and 1988. Barker's contributions towards preserving Tarrant County history are almost too numerous to mention. Notably, she can be credited for spearheading the efforts to save the Torian Cabin, which now sits on Main Street in Grapevine as one of the most treasured relics of Tarrant County's pioneer past. Barker also was instrumental in both starting and growing the Tarrant County Archives. In 1987, she developed the systems and policies for the archives, assumed its management and held that position on a volunteer basis until 2000. Dee Barker remains both a contributor to and supporter of the Tarrant County Archives.

### Scope and Contents:

#### City of Colleyville, undated, 1976-2010

The City of Colleyville Series contains various items related to the City of Colleyville, city planning, and events hosted in Colleyville. As a longtime resident of Colleyville, Dee Barker served on numerous task force committees. Many items pertain to the Colleyville Chamber of Commerce. The majority of items come from activities and planning throughout the 1990s, including items from the 1997 Master Plan Task Force and both the 1993 and 2000 Highway 26 Task Forces and sub-committees.

### **Tarrant County Historical Commission, undated, 1965-2012**

The Tarrant County Historical Commission Series contains various items related to Dee Barker's work with the Tarrant County Historical Commission and Texas Historical Commission. Items include bylaws. Barker was instrumental in both starting and growing the Tarrant County Archives. In 1987 she developed the systems and policies for the Archives, assumed management of the Archives and held that position on a volunteer basis until 2000. In 1993, she received the Jary Award for documentation of Tarrant County history. Barker's historical research documenting the Denton-Tarrant County boundary line supported Tarrant County's receipt of many millions of dollars in property taxes. The records relate to the Tarrant County vs. Denton County Court Case to Determine Boundary Between the Two Counties and contain documents, portions of maps, notes, and reports and letters to S.F. Johndroe 111 and Cantey and Hanger, L.L.P. This series also contains copies of the Texas Historical Commission's publication, The Medallion, from 1977-2001.

The Tarrant County/Denton County Boundary Court Case subseries contains materials that relate to Dee Barker's research collected for and during the Tarrant County versus Denton County Court Case to determine the boundary between the two counties.

This Photographs subseries contains various photographs of historical interest to Tarrant County. These include items not in Tarrant County, i.e. wooden oil derrick in Ranger, Texas.

This Media subseries contains oral histories of Colleyville residents F.O. Bone and Paul Pirkle and VHS tape recordings of Texas Historical Marker dedications made by Marvin Wilson when his wife Betty was Chair of the Dedication Committee.

### **City of Grapevine, undated, 1894-2006**

The City of Grapevine Series contains various items related to the 1999/2000 restoration of Torian Cabin and activities of the Grapevine Heritage Foundation. These include photographs, documents, artifacts, and newsletters. This series also houses several editions of the Grapevine Sun newspaper.

The Torian Log Cabin subseries contains various items related to the City of Grapevine's effort to restore Torian Log Cabin in 1999/2000.

### **Tarrant County Culture, undated, 1974-2010**

This series contains a variety of items that reflect aspects of Tarrant County's many cultures. The Entertainment subseries consists of files related to the Texas Rangers baseball team and Tarrant County museums. The Bell Helicopter Articles and Related Items subseries contains photocopied newspaper clippings about Bell Helicopter from 1984 written by Mark Thompson in the Fort Worth Star-Telegram. Also included are a response letter from Star-Telegram to the Barkers about their expressed concern over the series, a letter from the Bell Helicopter Office Workers Local Union assisting people in canceling their subscriptions to the Star-Telegram, and reactions to and editorials on the Mark Thompson series and articles. There are also images of Bell Helicopters included in this subseries. The Calendars subseries contains calendars which include Fort Worth Star-Telegram photography of Fort Worth and beyond from the 1990s and 2000s. The Magazines subseries contains various publications collected by donor, including Indulge.

### **Books, undated, 1969-1996**

This series contains books on Fort Worth, Tarrant County, and Texas history.
