Dear Ballinger:

We are pleased to know of your interest in obtaining a Recorded Texas Historic Landmark designation for St. Andrews United Methodist Church.

Enclosed are the 1992 guidelines and application form as well as a narrative on the St. Mary of the Assumption Catholic Church which will serve as a guide. The material from our archives file on the St. Andrews United Methodist Church is rather sketchy, but perhaps may be of some help.

Also enclosed is the Riverside United Methodist Church congregation narrative -- in event you decide later that you want a congregation historical marker.

Your nomination will need to include a historical photograph from at least 50 years ago, black and white photographs of all four sides of the church, a floor plan, and an architectural description.

When your nomination is complete, it should be submitted to me for review and critique by the Marker Committee.

Once the Tarrant County Historical Commission approves your nomination, we will forward it to the Texas Historical Commission in Austin for their review. Upon their approval, they will request payment of the marker fee and your approval of the proposed marker inscription prior to the casting of the marker. The completed marker will be shipped to the sponsor. A dedication usually follows, with participation by the marker sponsor, any local historical organization involved with the project, and the Tarrant County Historical Commission.

Please keep in touch as you conduct your research and write your nomination. We'll be glad to help direct your efforts. Good luck!

## ST. ANDREWS METHODIST CHURCH

The Methodist Episcopal Church was organized in annual Conference relations in New Orleans, <sup>Louisiana</sup> La. December 25, A.D., 1865, by Bishop Ghompson. The Conference then organized included Louisiana, Mississippi, and Texas, and was named the "Mississippi Mission Conference." Three annual sessions of this Conference was held and in January, 1867, the the Texas was organized out of the Mississippi Mission Conference, which included the entire State of Texas. There were eight annual sessions of the Texas Conference held, and it was during the eighth session of the Conference held at Marchall, Texas, January 7, 1874, that the "West Texas Conference" was organized, with Bishop Thomas Bouman, President. The ministers comprising the West Texas Conference were called to meet in Wesley Chapel Methodist Episcopal Church in Austin, Texas, January 22, 1874.

This Conference to date has five districts, 109 Pastoral Appointments, and a school that is a credit to the denomination, viz., Huston-Tillotson College, located at Austin, Texas. <sup>1</sup>

The districts are Austin-Victoria, Dallas, San Antonio, Waco and Western. St. Andrews Church is in the Dallas, District. <sup>2</sup>

When the Methodist Churches merged and became intergrated in 1965 St. Andrews became part of the Central Texas Conference.

Reverand James L. Wattley states that all this history to be true; except that he does not remember the White Street Church mentioned in #13. Of #3 he said Reverand D. C. Lacey gave him his first assignment in 1931. The Epworth League was started by Reverand F. L. Kirkpatrick. <sup>3</sup>

The West Texas Annual Conference was held at St. Andrews May 8-12, 1957.

According to Conference minutes, in 1957 J. G. Ounes was Dallas District Superintendent and L. L. Haynes preacher of St. Andrews. 1958 through 1960 T. M. Bruton was Dallas District Superintendent, and L. L. Haynes remained the preacher at St. Andrews. T. M. Bruton, now deceased, was the father-in-law of Alma Bruton. She is the present Historian of St. Andrews.

#### JAMES L. WATTLEY

James L. Wattley was born in 1891 in Navarro County, six miles from Corsicana, Texas. His parents were Enoch and Anna Wattley. In 1912 he joined Thompson Methodist Church at Prospect Street in Fort Worth, Texas. He became a visiting local preacher. 1931 he finished the Gammon Theology College in Atlanta, Georgia.

His first appointment was at Luling, Texas in 1931. Next he spent two years at St. Mark in Lockhart, Texas. He also pastored St. James in Temple, Texas. 1957 he was at Edna, Texas. 1958 he was on the Journal and Historical Commission of the Conference. 1959-60 he was assigned to Trinity Methodist at 428 McKinney in Dallas, Texas. In 1960 he was again on the Historical Commission and Journal of the Conference.

Reverend Wattley, now retired at age 94, lives in North Fort Worth and preaches occasionally.

After Rev. Wyatt came Rev. A. L. Carper, who built the basement of the church on South Main. Then after Rev. Carper came Rev. K. W. McMillan, Sr., who built the auditorium and installed the first pipe organ in 1921.

In 1925 Rev. T. H. Wyatt came and stayed one year. After Rev. Wyatt came Rev. J. W. Warren who served from 1926-1927).

Rev. R. M. Davis followed Rev. J. W. Warren. Rev. Davis served from 1927-1928.

Rev. K. W. McMillan returned in 1928 for the second time. Then Rev. Deslandes followed Rev. McMillan. After Rev. McMillan came Rev. J. H. R. Dudley. Then Rev. McMillan returned for the third time. During this time the Texas Highway Dept. bought our property on South Main. We didn't get enough money to rebuild, so we worshiped with Baker Chapel A. M. E. Church for a few months until we raised enough money to relocate. We then purchased property on the corner of E. Rosedale and Bransford.

Rev. J. H. Carruthers then followed Rev. McMillan. Rev. Carruthers served from 1945-1956. He brought us from E. Rosedale to our present location, 522 Missouri Ave.

Following Rev. Carruthers then followed Rev. L. L. Haynes in 1956. Under Rev. Haynes pastorate we completed paying for the church and installed the air-conditioning unit. Rev. Haynes remained with us until he retired in 1971.

Then followed Rev. Eric C. Purnell, our present pastor, who installed the present organ.



## CHURCH HISTORY

St. Andrews Methodist Church was organized by the late Rev. James W. Moore in the year of 1888, in the U. B. F. Hall on Calhoun Street, wherein is now called, Little Mexico. At the time of the organization, 15 members enrolled. The only survivors of this number being in the person of Mrs. Ollie Smith, who was then Miss Ollie Moore.

Because the membership was small and unable financially to pay the rent, Rev. Moore secured the Morning Chapel C.M.E. Church for two Sundays per month. Rev. Moore looked forward that this little church must be under its own vine and fig tree. So with the help of the Fifteen members and the public Rev. Moore secured a piece of property on Ninth Street which at that time was called Ham Branch and is now owned by the Rock Island R.R. and built our first Church. The carpenter work was done by the pastor himself. In the fall of 1888, the Bishop sent a Reverend Ford as pastor of St. Andrews. The membership being small was unable to support a pastor. Rev. Ford served this church without being paid a salary for one year. The Bishop then assigned Rev. D. C. Lacy to the Pastorate under whose leadership we built and owned our first parsonage, a three room house.

The church had grown to a self-supporting standard. It was under the Pastorate of Rev. Lacy that the Epworth League had its beginning. Being a prepared man in this special work of the church, Rev. Lacy was successful in getting the young people interested in the work and at this point the church began to grow spiritually, numerically, and financially. Rev. Lacy served here four years. The Bishop then sent Rev. J.M. Wormley under whose pastorate a piece of property was bought on Terrell Avenue and our first Church Building was moved on this spot of ground. The persons who came with the Church on Terrell Avenue and yet living and active members of the church are Sisters L. A. Cook, Lula M. Davis, and Ollie Smith.

We had many trials. We had the misfortune of having our church blown from its blocks. We went into debt trying to put the church on a more substantial foundation. We were locked out of the church but the members and friends rallied and in three weeks we re-entered the church and began our worship. During Rev. Wormley's stay here, he was married to a Mrs. Samantha Landrum, who was one of the tireless workers of St. Andrews'. Many souls were added to the church.

It was during Rev. B. J. Goff's Pastorate that we purchased the Missouri Avenue Methodist Church (white). This building was the first largest church the membership ever owned. We then made preparation to invite the district conference to our church. St. Andrews has the honor of permitting the first Southside Public School to be taught within its walls. Rev. E. L. Jackson was Rev. Goff's successor. The first two years of his pastorate was filled with many obstacles, so much so he had to often resort to some of the faithful members for his meals.

Like Paul, he stood the hardships and his last year was a successful one. Rev. J. W. Pinkney followed Rev. Jackson. After staying one year he was sent away and Rev. H. C. Cooper was sent to us. During his pastorate here, we remodeled our church, and again we entertained the District Conference. After one year Rev. Cooper was sent to another church.

Rev. A. Bethany was then assigned to St. Andrews. After serving a short time, God called him from labor to reward. He had fought a good fight and kept the faith. Rev. F. L. Thompson was sent to fill the unexpired term of Rev. Bethany. During Rev. Thompsons' pastorate, we elected our first organist, a miss Jimmie Norris. Mrs. Madie Johnson lent the Church her organ until we were able to purchase one. Rev. Thompson served us one year. St. Andrews had grown and was listed among the larger churches in the West Texas Conference. Rev. F. L. Kirkpatrick was then sent to us. He not only lead his flock, but all churches throughout the city would worship with us. It was under his pastorate that we invited our first annual Conference to our church. The pastor and his wife gave their consent for the dining hall to be held in their home. When Rev. Kirkpatrick came to us we had no parsonage, but during his stay we bought a house. The Ladies Aid society was organized during that time. The first president of the society was Mrs. Gracie Echols, who was a tireless worker. It was during her presidency that the Society took the responsibility of aiding in the furnishing of the parsonage and also aiding the trustees in their struggles. Rev. M. S. Jordan succeeded Rev. Kirkpatrick. Because of ill health, he stayed one year. Rev. A. Brown succeeded Rev. Jordan under whose pastorate the church purchased a house and lot at 724 White Street. The church prospered spiritually, and financially. The conference then assigned Rev. Moses Smith to us. Being a great evangelist, many souls were added to the church during his stay among us. Rev. I. H. Wyatt succeeded Rev. Smith. After surveying the locality of our church Rev. Wyatt decided to buy a more desirable church site. He with the trustees purchased property on South Main Street. Rev. Wyatt also devised great financial plans to raise funds for the indebtedness of the church. The parsonage on White Street was remodeled and refurnished. The cost of the site was \$6,225. The total sum raised during Rev. Wyatt's stay was \$2,000.00. He remained with us for three years. Rev. A. L. Carper was assigned to this now called Big South Main Street Methodist Church. Through the medium of great carnival features, large sums of money was raised. Sister Callie Cawthorne at one time raised Six Hundred Dollars alone.

One of the most memorable Easter Sundays in the History of St. Andrews membership was the day we marched into the basement of this great church. Under the pastorate of Rev. Carper we completed payment on the church lot. Under the strain of a great church debt, Rev. Carper partially lost his health. Rev. K. W. McMillan Sr. was sent to us. His fame as a builder went out throughout the West Texas Conference. It was during his stay that we bought Pews, Pipe Organ, and Pulpit Furniture. We also bought our parsonage and its furnishings. The church grew spiritually, numerically and financially. He stayed with us three years. Rev. T. H. Wyatt was again sent to us on a second term. Rev. J. W. Warren was then sent



to us. He was instrumental in obtaining the service of one of the best organists in the city in the person of Mrs. Rice. Many of the outstanding debts were liquidated. His stay among us was a pleasant one. Rev. R. M. Davis was then sent as pastor. He caused this great church to take the foremost rank in an all-around report to the District Conference as well as the Sunday School and Epworth League Conventions. After staying with us for two years he was then moved to another church. Rev. K. W. McMillan was sent back for a second term. This time he stayed with us for three years. Rev. G. A. Deslandes, who not only served as Pastor of St. Andrews, but looked upon the world as his parish was then sent to us. He filled his pulpit with christian dignity. He stayed with us for one year. Rev. J. H. R. Dudley was the next preacher sent to us. He came to us with courageous faith in God. His financial efforts were pleasing to our debtors His congeniality with his official cabinet cannot be surpassed. Rev. K. W. McMillan was then sent to us again for his third term. He remained with us until 1945.

### BRIEF HISTORY OF PRESENT PASTORATE

In 1945 by agreement between the eminent pastor, Dr. K. W. McMillan Sr. and me and with the approval of our Resident Bishop, R. N. Brooks, I was appointed to the pastorate of the Great St. Andrew's Methodist Church.

I found a well organized church that had followed its leadership through a number of years. I found \$10,000.00 in the bank for the building fund, all property paid for, three lots paid for on Humbolt Street to the credit of my predecessor.

We discovered that because of a new zoning regulation, we would not be able to put the kind of building we needed on that site so with the consent of the Quarterly Conference and the Board of Trustees we purchased some additional property adjoining our property and began raising money to build a new church.

As time rolled on, more and more we realized that we faced tremendous odds. We actually needed all of our space to build adequately for our needs and yet the job of buying a new location to build a parsonage and the kind of church we needed, the hill looked rather high.

In 1946 at the suggestion of a dear friend, Miss Sue Mann, we had a private conference with Dr. W. W. Ward, Superintendent of the Fort Worth District, about the possibility of buying the Missouri Avenue Methodist Church property. No one in the membership knew of the discussions and at that time the possibility looked so far distant that I felt it would be too far away to wait, for the patience of the membership was growing short and restless but we kept on raising money. In 1947 we put \$14,000.00 on the building fund aside from meeting all other local, district and annual conference obligations. We had the impression that if we raised our cash money up to \$30,000.00 we would start our construction, but at that point we discovered we would have to raise more money. We then sold the lots on Humbolt and held a series of conferences with Dr. Ward about buying the Missouri Avenue property. The community began to change fast from white to colored, and finally we decided the time was right for negotiations on a broader scale. We held our first joint meeting in the First Methodist Church, and for weeks and months we toyed with the problem. We faced opposition from both groups. Finally we called the Board of Missions and Church Extension for advice, and the representative was not favorably impressed with the idea and yet we had no assurance of any immediate aid from the Board in the beginning of a new church. In the face of all opposition and criticism, the pastor, quarterly conference and trustees decided to purchase the property. We had raised our cash on hand above \$40,000.00.

In 1950, we purchased the Missouri Avenue property for \$60,000.00. We sold the old property for \$20,000.00; \$18,000.00 cash. Today we have paid for the property and secured a loan of \$20,000.00 for the remodeling of the church and property. Our Loan was secured at 5% interest, 10 years to pay. We decided to do everything that should be done to make the buildings meet our needs. The Church and parsonage stands today as evidence of our struggles and dreams. We realize that God has had a hand in all our efforts. Therefore, we have pledged ourselves to use all our facilities and strength to the glory of God and His kingdom.

The going has not always been smooth, but thanks be to God who giveth us the victory. We faced some ugliness, but any minister must meet the unloveliness of life with courage. I personally believe that if God is for us, he is more than all the world against us. My Bishop and District Superintendent served as a source of encouragement and there were so many lovely loyal people until they overshadowed the attitude of the unlovely.

Now unto Him who is able to keep your feet from falling, to the all wise, all just God and to Jesus Christ, Our Father, be glory, honor, dominion and power now and forever more.

SOME FACTS ABOUT THE HISTORY OF ST. ANDREW'S  
UNITED METHODIST CHURCH

(As told by Mrs. E. L. Mayfield)

I came to St. Andrew's Methodist Church August 12, 1899 under the pastorate of Rev. E. L. Jackson. The church at that time was located on E. Terrell Ave.

After Rev. Jackson served, he was followed by Rev. J. W. Pinkney. Rev. Cooper succeeded Rev. Pinkney.

After Rev. Cooper came Rev. Bethany, who passed away while pastoring the church. Rev. Thompson was sent to fill Rev. Bethany's unexpired term.

After Rev. Thompson came Rev. F. L. Kirkpatrick. Due to some difficulty with St. Paul Dallas, we agreed with the Bishop to exchange Rev. Kirkpatrick for Rev. Jordan, who became the next pastor.

Following Rev. Jordan was Rev. A. Brown. Rev. Brown was the first pastor who took steps to move the church from Terrell Ave. He with the church bought property at 730 White St. The property was bought from Scott and Taylor Printers. Rev. Brown lived there as a parsonage.

Rev. Moses Smith succeeded Rev. Brown. Under Rev. Moses Smith's leadership, we purchased the property next door to the church on Terrell Ave. ,since the property on White St. was not suitable for a church. This property was bought from Rev. Manogan, a Baptist minister.

Next followed Rev. T. H. Wyatt. With Rev. Wyatt we sold the property on Terrell Ave. for \$6500 and bought property on the corner of South Main and Butler St. (Butler is now Rosedale St.) This property was bought from Rev. H. A. Boaz. On this lot was an old barn which we used for a church. It included an office which the pastor used for a church office. It was here that our first telephone was installed.

The cornerstone ceremony at St. Andrews Methodist Church took place on May 21, 1951.

Speakers at the all-day ceremonies were Bishop E. W. Keyyl of St. Louis, and Reverend Hayden Edwards of the Polytechnic Methodist Church. Reverend J. H. Carruthers, the pastor, estimated 1,200 took part in the program.

The ceremony was conducted on the church grounds by the Grand Lodge of the Free and Accepted Masons, Prince Hall Affiliation. <sup>2</sup>

On January 26, 1951 the Trustees of St. Andrews were given a Deed of Trust by T. L. Bradford, Jr. for Lots 7, 8, and 9 being a tract of land 150 ft. square located at the Northwest corner of the intersection of Missouri Avenue and Annie Street for \$20,000. This was payable in monthly installments of \$212 each, the first due on March 1, 1951 and the first day of the month thereafter until March 1, 1961 with all unpaid and accrued interest due.

Robert S. Mosby, District Superintendent and J. H. Carruthers, Pastor in Charge, joined in the execution of the Deed of Trust as required by the Discipline of the Methodist Church. <sup>3</sup>

On April 27, 1953 James F. Sartain sold Lot 10, Block 9 in the Alford and Veal Addition to the City of Fort Worth to the Trustees of St. Andrews Methodist Church for \$5,500. The Trustees were R. C. Bonner, M. L. Sneed, K. W. McMillan, Jr., J. Armstrong, John Echols, J. B. Yerwood, L. E. Trezevant, W. M. Berg and Perry Hollins.

They paid \$1,000 cash and gave two notes. Note one was for \$3,000 dated April 24, 1953 at 7%, and note two was for \$1,500 at 7% payable on or before December 31, 1954. They were secured by a Deed of Trust to Everett B. Comer, Trustee. <sup>4</sup>

This indebtedness had been secured by a Deed of Trust from the same Trustees of St. Andrews Methodist Church to T. L. Bradford, Jr., Trustee of Dallas, Texas. It now also included Lot 10 in Block 9 in the Alford



and Veal Addition. <sup>5</sup>

For the sum of \$5,000 payable in monthly installments of \$79.58 each, beginning February 1, 1955 all remaining unpaid principal, plus accrued interest was payable on March 1, 1961. <sup>6</sup>

On May 9, 1959 the authorized Trustees of St. Andrews Church gave a \$10,000 promissory note to Lacy Boggles for Lots 7, 8, 9, 10 in Block. <sup>7</sup>

The Trustees of St. Andrews, R. C. Bonner, M. L. Sneed, K. W. McMillan, Jr., L. W. Trezevant, S. E. Griggs, Dr. H. D. Robinson, J. C. McAlister, Edward J. Briscoe and F. M. Miller, gave a promissory note for \$6,000 to Lacy Boggess for Lots 7, 8, 9, 10 according to the Plat recorded in Book F, Page 328. <sup>8</sup>

On February 27, 1967 the Trustees, Edward Brisco, F. M. Miller, R. C. Bonner, Ruby Jones, Sam Griggs, L. E. Trezevant, Clyde Broadus, K. W. McMillan, J. C. McAlister, renewed and extended their obligation of the balance owed being \$2,577.78 to Lacy Boggess, Trustee for Mutual Savings and Loan for these lots. The original note was executed December 17, 1963 for the sum of \$6,000. <sup>9</sup>

On April 16, 1971 Trustees for Lots 7 through 10 were C. R. Broadus, K. W. McMillan, Lee Pinkston 11, Mrs. Ruby Jones, Clifford Davis, W. A. Miles, Edward Brisco, Robert Brewer, and T. J. Bass. The note was secured for the face amount of \$6,350 which represents the actual loan of \$5,000 to which \$1,350 interest at 10% accrued and was added to the loan. The note was secured and given renewal and the extension of \$1,593.85 on the original sum of \$6,000 made February 27, 1967 in Book 2002, Page 230. <sup>10</sup>
