In accordance with Local Government Code, the Auditor's Office conducted surprise cash counts at all eight Tarrant County Tax Office locations from January 21 – January 23, 2020.

The objectives of our review were to determine whether:

- Change funds and remittances were accurately recorded and properly reconciled to the respective accounts;
- Change funds were used only to make change in connection with collections payable to the County and were not used to make loans, advances, or to cash checks or warrants of any kind; and
- Physical safeguards were in place to protect County funds.

Of the eight locations counted, five locations had immaterial differences that will be recorded to their Over / (Short) general ledger accounts.
