Tarrant County Housing Department

The Tarrant County Community Development and Housing Division of the County Administrator's office, administers several community development and housing programs funded by the U.S. Department of Housing and Urban Development (HUD). The division assists eligible income qualified neighborhoods with ensuring public infrastructure is sustained and improved, public facilities are safe and viable, homeowners have safe and decent homes to live in, our homeless population is assisted and housed, and lastly families or persons that need housing have assistance or other resources available.

With firm foundations made with cities, over \$ 36 million in HUD public infrastructure funds has been spent in Precinct 3 alone for the last 39 years. Our office has been able to replace and build new water lines, sewer mains, streets, drainage systems, sidewalks and public facilities. Since 1975, Tarrant County Community Development and Housing Division has spent over \$13.2 million to assist homeowners to rehabilitate their aging homes to ensure that there are no threats of lead for our children, families can have a safe environment to live in and older adults can age in place with modifications necessary to improve quality of living.

Our homeless populations are served by our office administering HUD funds while non-profit agencies provide the majority of operational assistance. Our office works closely and has built a strong relationship with all agencies that impact the homeless. For our citizens that require assistance in public housing, Tarrant County has a HUD funded housing voucher program in which we provide an estimated 2,500 vouchers to pay rent monthly. The Housing Assistance Office also provides many other helpful programs; such as a family self-sufficiency program so that families will not have to depend on public assistance, employment search assistance, family learning programs and more. There is currently a waiting list of approximately 10,000 persons and the list will not re-open again till 2017.

Training Courses Offered for Veterans and Small Business

Tarrant County College & Texas Workforce Commission



A new partnership between Tarrant County College and Texas Workforce Commission (TWC) is bringing free training courses to local small businesses and veterans through two new programs.

The "Skills for Small Business" Program allows private businesses with fewer than 100 employees to qualify for up to \$1,450 for training. The program allows \$725 to train any existing employees and \$1,450 for newly hired full-time employees. They may take continuing education, credit, online or other unpublished courses currently available.

Eligible companies must be financially stable, in compliance with Unemployment Insurance contributions to TWC, and be in compliance with the Texas Business and Commerce Code. Each participating business partner will select training for its new and/or existing employees that will contribute to the enhancement of the business' operations. Training must be selected from active course catalogs/schedules. Examples of available courses include: Leadership Training, Computer Training, Customer



Service Training, and Languages.

The "Skills for Veterans" Initiative provides \$1,450 in tuition and fees for free skills enhancement training for any newly hired post 9/11 era vets who are newly employed by any private for-profit business, or private non-profit hospital. Participating businesses must employ at least one full-time, permanent individual and be financially stable.

Target occupations include but are not limited to: Dental Assistants and Hygienists; Heating, Air Conditioning, and Refrigeration Mechanics and Installers; Registered Nurses, Licensed Practical and Licensed Vocational Nurses, Nursing Aides, Orderlies, and Attendants; Medical Assistants; Pharmacy Technicians; Physical Therapist Assistants; Police and Sheriff's Patrol Officers; and Machinists.

Participating companies must be responsible for paying Unemployment Insurance contributions to TWC, and be in compliance with their reporting and payment requirements. They must also be in compliance with the Texas Business and Commerce Code. The "Skills for Veterans" Initiative program benefits must be used in a 12-month period. Veterans taking part in the program may take continuing education, credit or online courses.



Tarrant County Northeast Courthouse Construction Update



Construction continues for the NEW Northeast Courthouse

- Site utilities and rough-in for underground mechanical, electrical, and plumbing has been completed.
- 240 cubic yards of concrete were poured to finish the north half-slab.
- 396 cubic yards of concrete were poured almost completing the first floor south slab.
- Slab has been poured and materials are arriving for the mockup. (A mockup is
 a very small structure that will incorporate most of the exterior materials, so a
 "preview" of how the materials will look together in-place, how all the flashings will be installed and how maximum "building envelope" water-tightness
 can be achieved.)

Soon we'll see stud wall framing being erected, and by the first of January, it will be exciting to see the profile and volume of the new building!

Completion remains scheduled for December 2014.

Tarrant Riders Network



The Tarrant Riders Network, a community coalition of social service agencies, local government representatives, transportation providers and faith-based organizations, is trying to fix a big problem that may impact you, your parents, your children or your neighbor.

It goes like this.

When an older adult or someone with a disability is unable to drive, they still have to get to the doctor, the grocery store or the pharmacy. Family members often pitch in to get them where they need to go, but sometimes that's just not possible.

What to do?

If they live in Fort Worth, Richland Hills or Blue Mound, they may be able to access bus service or The-T's Mobility Impaired Transportation Service. If they live in other parts of Tarrant County, they may be able to get a ride from one of more than a dozen services, like Handitran in Arlington or the Northeast Transportation Service, NETS, that can take people places they need to go.

But those transportation services often have different age-eligibility requirements for passengers and some agencies have restrictions relating to the purpose of the trip or won't take you outside a certain geographic area. Also, most are booked solid and sometimes have to turn people away.



More than a year ago The Tarrant Riders Network, TRN, began regular meetings to see what could be done to address gaps in service and improve available transportation options.

TRN is working to increase public awareness in Tarrant County of existing transportation services, travel navigation and referral services.

TRN is also working to get more rides for more people. There are a few volunteer driver programs in the county, like Mid-Cities Care Corps, that give people rides. TRN is working to expand on that



idea and start volunteer driver groups at faith-based and service organizations across the county.

Volunteer driver programs already exist in San Antonio, Austin and in other states. They are definitely the fastest and cheapest way to get more wheels on the road and more passengers to their destination until other solutions are found.

An Historic Moment in Time

Tarrant County Historical Commission

In 1987, Texas officially established the County Historical Commissions in all 254 counties of the state.

But in Tarrant County by 1960 many educators and historians in this area joined forces to preserve the rich history of the county. County Judge Marvin Simpson appointed a Historical Survey Committee with Miss Ima Love Kuykendall as Chairman. They determined the condition of the Texas Centennial Markers, documented the cemeteries, historic buildings.

sites and landmarks. In 1975 the Committee became the Tarrant County Historical Commission with Mr. Bennett Smith as Chairman.

These early members began collecting artifacts of county history storing them in various places including homes and a vacant school. Finally, space was found in the basement of the old Civil Courts Building and the Tarrant County Archive became a place where the material could be made useful to the public. From 1982 until 2001 the collection was manned by volunteers. Since 2001, the archive has been funded by the county and is open daily. The commission shared space with the Archive until February, 2008, when both were moved to their present locations in the Plaza Building.

The first Texas Historical Marker was received in 1962; today we have more than 360.

Tarrant County received recognition at the Texas State Historical meeting in 1972 and has been honored with awards for preservation work continuously thru the 2012 Distinguished Service Award recently received in Commissioners Court from our court liaison, Commissioner Gary Fickes.

The Commission meets in alternate months beginning



in January each year. Our members are active in historical preservation through educational programs locally and in cooperation with the Texas Historical Commission and its regional workshops. For more information contact us at 817-884-3271. We are all volunteers, so leave a message.

What is Alzheimer's disease?

Alzheimer's disease is an irreversible, progressive brain disease that slowly destroys memory and thinking skills and, eventually even the ability to carry out the simplest tasks of daily living. In most people with Alzheimer's, symptoms first appear after age 60. Alzheimer's disease is the most common cause of dementia among older people.

The disease is named after Dr. Alois Alzheimer. In 1906, Dr. Alzheimer noticed changes in the brain tissue of a woman who had died of an unusual mental illness. Her symptoms included memory loss, language problems, and unpredictable behavior. After she died, he examined her brain and found many abnormal clumps (now

called amyloid plagues) and tangled bundles of fibers (now called neurofibrillary tangles).


Plaques and tangles in the brain are two of the main features of Alzheimer's disease. The third is the loss of connections between nerve cells (neurons) in the brain.

Although treatment can slow the progression of Alzheimer's and help manage symptoms in some people, currently there is no cure for this devastating disease.

Stages of Alzheimer's Disease

- During the preclinical stage of Alzheimer's disease, people are free of symptoms, but toxic changes are taking place in the brain. Abnormal deposits of proteins form amyloid plaques and tau tangles throughout the brain, and oncehealthy neurons begin to work less efficiently. Over time, neurons lose the ability to function and communicate with each other, and eventually they die.
- The damage spreads to a nearby structure in the brain called the hippocampus, which is essential in forming memories. As more neurons die, affected brain regions begin to shrink.
- By the final stage of Alzheimer's, damage is widespread, and brain tissue has shrunk significantly.

Changes in the brain in Alzheimer's Disease



As Alzheimer's disease progresses, neurofibrillary tangles spread throughout the brain (shown in blue). Plaques also spread throughout the brain, starting in the neocortex. By the final stage, damage is widespread and brain tissue has shrunk significantly.

• State highways 114 and SH 121 are now in their final patterns, and all lanes are now open! NorthGate and the Texas Department of Transportation (TxDOT) will now begin to work on minor changes and punch list items. We appreciate everyone's patience and support while we built the DFW Connector!

 NorthGate is now shifting its focus to rebuilding FM 2499 from SH 121 to Denton Creek. Earlier this year, TxDOT was able to provide funding for

this additional work, which was initially part of the DFW Connector project scope. The FM 2499 mainlanes, northbound FM 2499 frontage road, Stars and Stripes Way and Grapevine Mills Boulevard intersections, as well as the bridges over Denton Creek will be rebuilt as part of this project. Construction is set to be complete in 2017.

• North Tarrant Express: The NTE project is nearly 75 % completed. In October, we completed the demolition of the last cross-street bridges along the corridor, opened the new Iron Horse bridge and continued construction on the Union Pacific rail bridge. The construction of exit and entrance ramps in their final configuration is well underway, especially in the Mid-Cities area. closures; rain and snow conditions can postpone work. (See photo)


• I-35W: Work continues north of I-820, with extensive work at the Basswood Blvd. and Western Center Blvd. intersections, and on the direct connectors from I-35W to 287. For regular updates on construction activities, please go to www.NorthTarrantExpress.com; lane closures are posted on the Fort Worth page of the NTE Communities section.

TxDot - N Tarrant Office 817-399-4300 www.txdot.gov • The \$11.4 million SH 26 project from Brumlow Avenue/Pool Road to John McCain Road in Colleyville continues to progress. Ongoing work includes the prepping of the new northbound lanes for concrete pavement and the construction of the bridge over Big Bear Creek. Pavement installation for the northbound lanes is estimated to be complete before the end of the year, weather permitting. Once the concrete pavement is

installed, motorists will be shifted to the northbound lanes so that the southbound lanes can be reconstructed. Southbound reconstruction is scheduled to start early next year.

• Two lanes of traffic will be maintained during peak driving times. The project is widening the road to three lanes in each direction with raised curb medians and left turn bays and is estimated for completion in 2014.

• On August 20, 2013 the City of Southlake awarded the lowest bidder, Wilson Contractor Services, LLC, the FM 1938 City Water Line and Sanitary Sewer Utility Relocation Project in the amount of \$1,845,378. The contractor anticipates beginning this project late November and last approximately nine months.

Moving existing utilities (water, wastewater, gas, phone, electric and cable lines) is the first stage of the FM 1938 Phase II project. The Texas

Department of Transportation will move forward on the FM 1938 Phase II improvements once all utilities are relocated.






New Fort Worth District Engineer Announced

The Texas Department of Transportation (TxDOT) announced that on Nov. 1, Brian Barth, P.E., was promoted to Fort Worth District Engineer. Barth will oversee the planning, designing, building, operation and maintenance of the state transportation system for the nine-county Fort Worth District in his new role. He has served as the Fort Worth District's deputy district engineer since 2009.

A 25-year member of the TxDOT family, Barth began his career as an engineering assistant in the Dallas District after graduation from the University of Texas at Austin with a bachelor's degree in civil engineering. In 2003, Barth was appointed as the Dallas District's director of transportation planning and development. Since 2009, Barth had served as the Fort Worth District's deputy district engineer, providing joint oversight and development of over \$6

billion in improvements from the DFW Connector, North Tarrant Express, I-35W, SH 360, I-30, Chisholm Trail Parkway.

Barth's appointment fills the vacancy left by Maribel Chavez who retired on Aug. 31.
