

Furthermore, this schedule separates the new, subsequent, issuance of citations, notices, writs and service of process/issuance. To determine amount of fees/court cost due at time of filing, please calculate:

Applicable Pleading Filing Fee	Example: Modification	\$30.00
+ Process Service/Issuance Fee	+ Citation	\$8.00
+ Fee for Serving Process	+ Service	<i>\$75.00</i>
= Total Court Cost	=	\$113.00
