AFFIDAVIT

According to Texas Commission on Environmental Quality Rules for On-Site Sewage (OSSFs) Facilities, this document is filed in the Deed Records of Tarrant County, Texas.

I

The Texas Health and Safety Code, Chapter 366 authorizes the Texas Commission on Environmental Quality (commission) to regulate on-site sewage facilities (OSSFs). Additionally, the Texas Water Code (TWC), §5.012 and §5.013, gives the commission primary responsibility for implementing the laws of the State of Texas relating to water and adopting rules necessary to carry out its powers and duties under the TWC. The commission, under the authority of the TWC and the Texas Health and Safety Code, requires owners to provide notice to the public that certain types of OSSFs are located on specific pieces of property. To achieve this notice, the commission requires a recorded affidavit. Additionally, the owner must provide proof of the recording to the OSSF permitting authority. This recorded affidavit is not a representation or warranty by the commission of the suitability of this OSSF, nor does it constitute any guarantee by the commission that the appropriate OSSF was installed.

II

An OSSF requiring a maintenance contract, according to 30 Texas Administrative Code §285.91(12) will be installed on the property described as (insert legal description):

This OSSF shall be covered by a continuous service policy for the first two years. After the initial two year service policy, the owner of an aerobic treatment system for a single family residence shall either obtain a maintenance contract within 30 days or maintain the system as prescribed by law. Upon sale or transfer of the above-described property, the permit for the OSSF shall be transferred to the buyer or new owner. A copy of the planning materials for the OSSF may be obtained from the Tarrant County Public Health Department.

**The following information is required to process your Tarrant County Residential and Non-Residential On-Site Sewage Facility application:**

1. A site evaluation of the proposed disposal field area.
2. A completed application **signed by the owner of the property**. If the developer/builder still owns it at the time of application, they are the owner and must sign the form.
3. Fees - Two hundred and sixty dollars (\$260.00) which covers application, assessment, plan review, two inspections and state mandated fee.
4. If the property is in the Extra-Territorial Jurisdiction (ETJ) of a city exercising its authority (Fort Worth, Mansfield, Haslet) you must include clearance documentation from the city.\*

At this point the information will be reviewed, the site inspected and the minimum system requirements established. If the site is acceptable for a standard septic system you will receive a specification sheet detailing the minimum tank capacity and drainfield size. If the site is unacceptable for a standard system you will be notified of the need to install an alternative system. There are many different types of alternative system and a list of common ones can be provided.

Property Approved for a **Standard System**:

A design must be submitted showing the following:

- a. Property lines and dimensions (properties of several acres - just show distance to the closest line).
- b. Proposed location of dwelling (including driveways, decks, and other permanent structures).
- c. Proposed location of septic system including tanks and disposal field showing dimensions and setbacks.
- d. Proposed location of well(s), if applicable. (Include wells on adjacent property if within 100 feet).
- e. The 50- and 100-year flood elevation if present on the property.

A scale drawing is preferred, if not it must be representative and accurate. This drawing may be completed by the proposed installer (this includes homeowners, provided no-one is compensated for any work done on the system).

Property Requiring an **Alternative System**:

Alternative systems must be designed by a Registered Professional Sanitarian or Registered Professional Engineer.

Any alternative system proposing surface discharge, e.g., sprinklers, low pressure emitters, must also have the following documentation: (1) A copy of a service contract that lasts for two years and (2) Proof of filling from the County Clerk for an affidavit indicating that a surface discharge system is on the property. A separate \$15.00 fee for the Tarrant County Clerk is required for filing affidavits.

### **All Systems**

Upon review of the submitted materials, the plan will either be approved or denied. If denied, the applicant will be notified and the reasons given. If approved, the plan will be stamped and initialed. A copy of the stamped design will be given to the installer. The stamped diagram is the permit to construct. **Any installation that is done without a stamped diagram in place will be considered illegal.** Notification for inspections must be made at least 24 hours in advance of requested inspection. Inspections must be performed within five working days of the request. At the time of the inspection, tanks must be set with all connections made, trenches/beds dug and leveled with rock if applicable, distribution piping laid, and backfill material must be on site. Alarms, pumps, filters and other required equipment must be installed to allow testing for proper operation. Electrical hookups must be complete.

If additional inspections are required due to problems with the construction, a fee of \$75.00 is required.

Upon completion of the system inspection(s) a permit to operate is issued. There may be conditions associated with the permit to operate and these conditions must be met.

If you are building within a City, you should check with the city staff as to the availability of connection to a central sewer system. If connection is possible then a permit cannot be issued for a new or repaired on-site system.

## HOW MUCH LAND IS REQUIRED FOR SEWAGE-SEPTIC

### FACILITY?

This is not an easy question to answer. The general state minimums are:

- 1 acre for land with a water well and sewage/septic facility, **OR**
- 1/2 acre for land with only a sewage facility.

The size requirements of a piece of property apply when it is divided. If you have an existing piece of land smaller than the above, then you must submit to the Tarrant County Health Department a professional design showing how you can get a legal system on your property. No matter how big or how small, each piece might not have enough if they have a well, stock pond, creek, big house, garage, etc. Be sure to read the next question.

## I AM SPLITTING UP A PIECE OF LAND, HOW SMALL CAN I MAKE IT?

If you will have On-Site Sewage/Septic Facilities, the state law has 2 possibilities: **You will need:**

- 1 acre if you might have a well, **OR**
- 1/2 acre if you will only have a public water supply.

However, you must have enough land to meet the requirements for the system you need. In Fort Worth's ETJ, you are required to have a minimum of 1 acre.

Remember, old, existing, recorded property is treated on an individual basis.

### WHAT IS THE COST?

The City of Fort Worth charges \$15.00 for parcel review and verification.

The following information is necessary for verification and approval. Any one of the **three** criteria noted below may be met:

1. A copy of a current warranty deed / vendor's lien complete with survey and legal description and filing information – AND – a copy of all warranty deeds filed dating back and including the date of **April 26, 1993**, complete with survey and legal description and filing information; **or**,
2. A copy of a current recorded plat noting subdivision, lot and block information and filing information – AND – a copy of all recorded plats filed dating back and including the date of **April 26, 1993**, noting subdivision, lot and block information and filing information; **or**,
3. A copy of a current warranty deed and a copy of all warranty deeds filed **after April 27, 1993** – AND – a notarized statement from your surveyor or title company attesting that the property was thoroughly researched and did not discover and/or find any other recorded deeds or plats filed for record **prior to April 27, 1993**.

The above information may be obtained from the County Court House for the County in which the property is located. Upon receipt of this information a thorough review will be made, if all requirements are met a Property-Subdivision letter will be issued.

**There is a \$25.00 Fee due at time of application. Make checks payable to the City of Fort Worth.**

## RESIDENTIAL ON-SITE-SEWAGE/SEPTIC FACILITY

### HISTORY

On April 27, 1993, the Tarrant County Commissioner's Court ruled that, consistent with state platting law, no permit shall be issued by the County Health Department for a septic type on-site-waste system unless the platting requirements of the city with jurisdiction have been met. On June 30, 1993, the Fort Worth City Plan Commission issued a policy that **lots existing prior to April 27, 1993, MUST BE PLATTED BUT BE A MINIMUM 1-ACRE.** Any Lot greater than 5 acres is **EXEMPT** from platting but must be verified by the city having jurisdiction before a septic system permit will be granted.

From time to time, property in the FTJ is either subdivided without benefit of patting or a home is actually constructed and cannot comply with the lot size requirements. We ask you to please inform your respective **Real Estate Associates and Builders** of this requirement so that further problems can be averted.

### REQUIREMENTS

When applying for a residential-on-site-sewage/septic facility permit, approval must first be obtained from the City. The following information is necessary for verification and approval and may meet any one of the 3 criteria noted below:

Applicant Name, Contact Number, Complete Mailing Address, and Property Address, **PLUS:**

1. A copy of a **CURRENT** warranty deed complete with survey and legal description and filing information – AND – a copy of all warranty deeds filed dating back and including the date of April 27, 1993, complete with survey and legal description and filing information; **OR,**
2. A copy of a **CURRENT** recorded plat noting subdivision, lot and block information and filing information – AND – a copy of recorded plats filled dating back and including the date of April 27, 1993, noting subdivision, lot and block information and filing information; **OR,**
3. A copy of a **CURRENT** warranty deed and a copy of all warranty deeds filed after April 27, 1993 – AND – notarized statement from your surveyor or title company attesting that the property was thoroughly researched and did not locate any other recorded deeds or plats filed for record prior to April 27, 1993.

The information above may be obtained from the County Court House in which the property is located. Upon receipt of this information a thorough review will be made, if **ALL** requirements are met a Property-Subdivision letter will be issued.
