This notice concerns 2016 property tax rates for TOWN OF NORTHLAKE TOWN OF. It presents information aboutthree tax rates. Last year's tax rate is the actual rate the taxing unit used to determine property taxes last year. Thisyear's effective tax rate would impose the same total taxes as last year if you compare properties taxed in both years.This year's rollback tax rate is the highest tax rate the taxing unit can set before taxpayers can start tax rollbackprocedures.
