The Auditor's Office conducted selected procedures to provide accountability and cut-off procedures for the transfer of authority. Since the scope of this review was limited in nature, the Auditor's Office does not opine on the Tax Office's financial statements and internal control structure. Based on the results of the testing, the transfer of authority appears to be complete without exception.

SUMMARY

On May 24, 2011, the Honorable Ron Wright replaced Betsy Price as Tarrant County Tax Assessor-Collector. The Auditor's Office conducted selected procedures to provide accountability and cut-off procedures for the transfer of authority to the incoming Tax Assessor-Collector. Since the scope of this review was limited in nature, we do not opine on the Tax Office's financial statements and internal control structure. Based on the results of our testing, the transfer of authority appears to be complete without exception. We performed the following procedures:

- Reviewed and reconciled cash balance as of May 23, 2011.
- Verified the change of the officeholder's name on all Tax Office bank accounts.
- Reviewed documentation for the change of authorized signatures related to accounts payable.
- Determined whether outgoing officeholder's access to County systems and applications were deactivated.
- Verified receipt of out-going officeholder's building access card and parking Chubb card.
- Reviewed the incoming officeholders Official Bond and Oath on file with the County Clerk's Office.
- Verified the completion of Tax Office deputations.

BACKGROUND

The Tax Assessor-Collector assesses and collects taxes on property in Tarrant County and for 55 other taxing units. Also, the Tax Assessor-Collector is responsible for motor vehicle registration and issuing beer, wine, and liquor licenses.

During the fiscal year 2010, the Tarrant County Tax Office assessed and collected approximately \$3 billion for property taxes, \$318 million for motor vehicle registrations, and \$2 million for beer, wine, and liquor licenses.

We appreciate the cooperation of the Honorable Ron Wright and his staff during our review. We look forward to working with the Tax Office in the future. In addition, we express gratitude to the Honorable Betsy Price for the cooperation extended to the Auditor's Office during her term.
