

#### **About Disaster Loans**

The U. S. Small Business Administration (SBA) provides low-interest, long-term disaster loans to businesses of all sizes, private non-profit organizations, homeowners, and renters to repair or replace uninsured/underinsured disaster damaged property. SBA disaster loans offer an affordable way for individuals and businesses to recover from declared disasters.

The Texas Disaster Declaration has been issued. If you are in need of assistance, now is the time to apply!

#### TEXAS Declaration #16381 (Disaster: TX-00544) Incident: CORONAVIRUS (COVID-19)

Updates and tips for applicants of the SBA Economic Injury Disaster Loan Program:

- The SBA is trying to expedite the process, so the 4506-T (Tax Release Authorization form) is waived on an application, for now, on loans less than \$500,000. However, private non-profit firms still must turn in a 4506-T form.
- You will have a 12-month loan deferral period. (Even though that is not on the Fact Sheet)
- Collateral is still required for loans higher than \$25,000.
- Don't lose your username and passcode, because if you do, then you will have to start the application again.
- Your application number is pertinent when calling in for the status of the loan or for additional information. Ask for their Case Manager and then you can be routed to their Loan Officer.

Collecting data online is the best way to get your application to the SBA. If, however, you are unable to provide portions of the required information online, you may use one of the following methods to deliver documents to the SBA. **IRS Federal Income Tax Filing Deadline Extended from April 15, 2020 to July 15, 2020.** Taxpayers can also defer federal income tax payments due on April 15, 2020, to July 15, 2020, without penalties and interest regardless of the amount owed. This deferment applies to all taxpayers, including individuals, trusts and estates, corporations and other non-corporate tax filers as well as those who pay self-employment tax.

## **United States Census 2020 Update**



Even though the County, the State, and the Nation are working to meet the challenge of the coronavirus pandemic, one of the most important civic duties that all Americans must do every decade is upon us: The 2020 Census. Every ten years, every resident in the United States is counted.

This count is incredibly important: the Census determines state apportionment of seats in the US Congress, representation in the Texas Legisla-

ture, and billions of dollars in federal appropriations for everything from healthcare funding to transportation dollars.

As of April 7, 2020, Tarrant County had a 46.9% response rate. The County's response rate is well ahead of the State's (40.4%) and the nation (45.1%). The better count in Tarrant County will mean that our citizens will be properly represented and receive the federal funds that our community should get.

It's not too late to take the Census. If you haven't yet taken the 2020 Census, please go online to <u>my2020census.gov</u> or call 844-330-2020. The 2020 Census is available online, by phone and by mail.
