ORDINANCE NO. 429
ADOPTION OF LAKESIDE TOWN BUDGET

AN ORDINANCE ADOPTING THE BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2023, THROUGH SEPTEMBER 30, 2024, FOR THE TOWN OF LAKESIDE, TEXAS, AND DIRECTING IT TO BE FILED AS REQUIRED BY LAW

WHEREAS a proposed budget for the fiscal year of October 1, 2023, through September 30, 2024, has been filed by the Town Administrator of the Town of Lakeside; and,

WHEREAS notice of a meeting on the budget has duly and legally been given as required by law; and,

WHEREAS, after consideration of the financial condition of the Town of Lakeside and after consideration of all other factors affecting same, the City Council is of the opinion that a budget should be approved and adopted for the 2023-2024 fiscal year;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF LAKESIDE, TARRANT COUNTY, TEXAS:

1. The City Council hereby adopts and approves the budget attached hereto and made a part hereof as if fully set out in this Ordinance as the budget for the Town of Lakeside for the fiscal year of October 1, 2023, through September 30, 2024.
2. It is directed that the budget be filed with the City Secretary of the Town of Lakeside and with the County Clerk of Tarrant County, Texas, and thereby maintained as required by law.
3. It is further directed that the City Secretary post the budget adopted herein on the city's web site.
