An owner or operator of a vehicle that ha been removed and placed in a vehicle storage facility or booted without the consent of the owner or operator of the vehicle is entitled to a hearing, if the owner/operator files with the court, a written request for the hearing **BEFORE THE FOURTEENTH (14TH) DAY AFTER THE VEHICLE WAS REMOVED/BOOTED (STRIKE ONE).** In computing time under this subsection, Saturdays, Sundays and legal holidays are excluded. A hearing under this chapter shall be in the Justice Court in the county which vehicle was towed/booted. **Note: A person who fails to deliver a request in accordance with Occupations Code, Section 2308.456(a) waives the right to a hearing. *All persons should consult the <u>Texas Occupations Code</u> Chapter 2308 for complete information**.
